You are, therefore, required to streamline such activity and establish a Cell/Facilitation Center at your office and to authorize a responsible officer/official, to receive verification letters of surety documents from District Court Badin online through E-mail/Whatsapp and send its verification back through same mode and so also through courier, to curb the delay and mal practice, minimizing the human intervention.
